# **CHAIRMAN'S REPORT SEASON 2018**

3rd January 2018

In a similar fashion to the 2017 season, the race for the Premier Division title was for a considerable period contested by two clubs, Knowle & Dorridge and Berkswell, with the title being realistically decided on the penultimate weekend of the season when the eventual winners Berkswell defeated last year's champions Knowle & Dorridge. The game itself proved to be a fantastic example of the high quality of cricket played by these two clubs throughout the 2018 season. Berkswell won the Premier Division by 18 points and also won the T20 competition to complete a superb season double.

Both Wolverhampton and Ombersley eventually succumbed to relegation in what was a close fought battle between a number of clubs, Ombersley eventually relegated by only two points.

In the First Division, Kidderminster return to the Premier Division at the first attempt as Division One champions. In another tight finish, Shifnal also secured promotion on the final day of the season and by the slightest of margins. One point separated them from the unfortunate Bridgnorth. Former Premier Division Champions Wellington were relegated to the Shropshire County League. Brockhampton, whilst finishing in the relegation places, avoided relegation as the Management Board ruled that C & R Hawks were ineligible for promotion from Division Two after undergoing a Ground & Facility audit.

In the Second Division, Harborne were crowned as Champions with C & R Hawks finishing as Runners-up; however, C & R Hawks, as mentioned earlier, were ineligible for promotion which allowed Brockhampton to retain their place in Division One. Another tight relegation battle resulted in relegation for both Coventry and North Warwickshire and Astwood Bank.

In the Third Division, the Champions were Stourbridge, one of the original Birmingham & District Cricket League Clubs, with Rugby finishing as Runners-up.

However, and of much concern, the number of disciplinary cases experienced in 2<sup>nd</sup> XI cricket increased significantly during the season. Fines continue to be part of the other income of the League for disciplinary reasons and non-compliance with League Rules. In the main, these matters were managed, adequately, within the League Rules and by the Clubs concerned. I would reiterate that, at the commencement of the season, officers of all League Clubs sign a declaration to the effect that the Club will comply with the Spirit of Cricket in all respects and I, once again, urge all officials and players to recognise their obligations in these matters.
